**ADMISSION OF NONRESIDENT STUDENTS
(and tuition)**

Students who do not legally qualify as “resident” of the School District who are admitted by the School Board will be charged tuition except for the following:

1. To bring into the school system on occasion students from other countries who are the guests of School District residents under exchange programs that have been recognized for purposes of school attendance by the School Board. (see Policy JFABB)
2. Students who attain senior status at the end of a school year, who reside in Goffstown and move out of Goffstown during their senior year, may continue on to graduation with the approval of the Principal and the Superintendent.

Except as nonresident students are given special consideration for the reasons stated above, or unless enrolled through an agreement with another school system or agent, all nonresident day students, be allowed to continue in the School District by the School Board, will be charged tuition based on a per pupil cost determined in accordance with state law. This cost will be determined annually, and the tuition set by the School Board.

A tuition student will not be admitted without School Board approval. This does not include students from the sending School District of New Boston.

Nonresident students may attend School District schools when their attendance has been approved by the School Board. Tuition will be charged at a rate set by the School Board and billed quarterly in advance to the sending School District or parent responsible for payment. When a sending School District is responsible for tuition, approval must be received from the sending School District’s School Board. There is no bus transportation provided to non-resident students who attend Goffstown schools.

1. Nonresident students who show sufficient evidence that they will be establishing residency in the School District may, at the discretion of the School Board, be granted a grace period from tuition charges not to exceed 30 calendar days from the first day of the school year. Tuition charges will begin on the 31st calendar day and continue until the student becomes a legal resident of the District.
2. Nonresident Seniors who moved out of the School District 30 days prior to the end of the school year may, at the discretion of the School Board, be granted a grace period from tuition charges not to exceed 30 calendar days from the last day of the school year. Tuition charges will begin on the day the senior is no longer a legal resident of the District and end, with the approval of the School Board, on the 31st calendar day prior to the last day of the school year.
